



### INVITATION TO BID (IB)

The Department of Tourism (DOT) Bids and Awards Committee (DOT-BAC) invites event organizers with experience in organizing a fashion show within the last five (5) years to bid for the hereunder project:

Name of Project: "Arts and Heritage... in style" Project

Brief description of the Project: An event showcasing the unique, products, festivals and destinations of each region in the country.

Approved Budget for the Contract: One Million Pesos (P1,000,000.00) inclusive of all applicable taxes

Prospective bidders should have completed a similar project with an amount of at least 50% of the proposed project for bidding within the last five (5) years from the date of submission and receipt of bids, and have key personnel and equipment (owned, leased or under purchase) available for the execution of the project. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
