



**INVITATION TO BID FOR BOOTH DESIGN AND CONSTRUCTION FOR THE PHILIPPINE BOOTH AT THE
43RD INTERNATIONAL BOAT SHOW DUSSELDORF OR BOOT DUSSELDORF 2012**

1. The Philippine Department of Tourism (PDOT) is in need of the services of a company based in Europe engaged in the business of designing and constructing booths for travel and consumer fairs for the Philippine Stand at the 43rd International Boat Show Dusseldorf or Boot Dusseldorf 2012 at the Dusseldorf Exhibition Center, Dusseldorf, Germany to be held on January 21 to 29, 2012.
2. The PDOT, has a budget in the amount of **TWENTY THOUSAND TWO HUNDRED FIFTY EUROS (Euro20,250.00) or its Philippine peso equivalent, inclusive of taxes.** This amount is the Approved Budget for the Contract (ABC) for payment of designing and constructing the Philippine Stand for the above mentioned travel fair for a period of one (1) month.
3. The PDOT - Bids and Awards Committee (BAC) now calls for the submission of bids for the said Project. Interested designers and contractors, with at least three (3) years of existence and with relevant experience in the performance of the deliverables enumerated in the Project's Terms of Reference must submit their bids (stamped received in Manila) on or before December 26, 2011 through mail or courier (please indicate name of project: 43rd International Boat Show Dusseldorf or Boot Dusseldorf 2012) addressed to USEC. MYRA MARIE D. VILLARICA, DOT-BAC Chairperson, c/o Mr. Florencio S. Capati, Jr., DOT-BAC Secretariat, Rm. 314, DOT Bldg., T. M. Kalaw St., Ermita, Manila, Philippines, 1000. Bids received/stamped in Manila after 5:00pm MANILA TIME of December 26, 2011 shall not be accepted for being late and shall be returned by the PDOT-BAC to the sender/bidder. Bidders are required to submit three (3) copies of bidding documents.
4. The PDOT-BAC shall select the winning bid based on the evaluation by the BAC on the bidder's compliance with all the requirements for bidding as specified in the Checklist (Annex A), relevant experience (Annex B), Omnibus Sworn Statement (Annex C), capability to perform all the deliverables enumerated in the Terms of Reference (Annex D) and Financial Proposal (Annex E). The Criteria set by the PDOT-BAC in selecting the winning bid are as follows: Company Background and Booth Design and Layout. The forms for Annexes A, B, C, D, and E may be downloaded from these websites: www.tourism.gov.ph, www.wowphilippines.com.ph, and www.philgeps.net. Bids received with financial proposal in excess of the ABC mentioned in Paragraph No. 2 shall automatically be rejected.
5. Bidders are required to submit and include in its bid proposal a Bid Security in the form of Manager's Check issued by a bank in good standing and payable to the PDOT in the amount equivalent to two percent (2%) of the ABC (Euro405.00 or its Philippine Peso Equivalent) as mentioned in Paragraph No. 2. The Bid Security will be returned to the bidders after the bidding.
6. Eligible Bidders may be required to make a presentation of their bids.
7. Amendments and clarifications during the bidding stage regarding this Invitation to Bid may be sent by, and or made available to the bidders through email at bac@tourism.gov.ph until December 16, 2011 only.
8. The PDOT-BAC reserves the right to reject any or all bids, declare a Failure of Bidding at any time prior to the contract award, or not to award the contract, without thereby incurring any liability and make no assurance that a contract shall be entered into as a result of the bidding. Likewise, the PDOT-BAC may waive any minor defect therein and accept the offer most advantageous to the government. Further, the PDOT-BAC assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
