## I. BACKGROUND

The Department of Tourism is currently engaged in the Tourism Convergence Program with key national government agencies on projects and activities relevant to Tourism and Hospitality, Education, Training, and Research. These partner agencies were enjoined to participate and extend technical inputs based on their mandate and provide relevant assistance as may be required by the program. In the course of implementing the convergence program between DOT and partner agencies, the formation of Joint Working Groups (JWGs) / Sub-Committees was undertaken to draw support and complement DOT initiatives in the areas of: (1) Standards Review and Development; (2) ASEAN Mutual Recognition Arrangement (MRA) on Tourism Professionals; (3) Industry Linkages and Partnerships; (4) Research and Innovation Programs; and (5) Education Tourism, to name a few.
