Contract for the Procurement of Land Travel Management Services for the 21st World Travel and Tourism Council (WTTC) Global Summit Land Transportation Requirements (Lot 8) - Vans

This Contract for the Procurement of Land Travel Management Services for the 21st World Travel and Tourism Council (WTTC) Global Summit ("Agreement") is made this APR 1 5 2022 2022, in the City of Makati, by and between:

The DEPARTMENT OF TOURISM (DOT), a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its UNDERSECRETARY WOODROW C. MAQUILING, JR. and hereinafter referred to as the "PROCURING ENTITY";

-and-

CIRCLE TRANSPORT CORP., a private entity duly organized and existing under the laws of the Philippines, with business address at 60 Aurora Boulevard, G. Reyes, San Juan City, Metro Manila, NCR, authorized and represented herein by its OPERATIONS MANAGER EDNA C. MAMUYAC and herein referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, under Republic Act No. 9593 or the Tourism Act of 2009, the PROCURING ENTITY, is mandated to provide an integrated market development program to attract people to visit the Philippines and enhance the prestige of the country and the Filipino people in the international community;

WHEREAS, under the initiative of the PROCURING ENTITY, the Philippines has been selected to host the 21st World Travel and Tourism Council (WTTC) Global Summit ("Summit") on 20 to 22 April 2022 (originally scheduled in April 2021), which is projected to bring over 800 delegates composed of officials and representatives from tourism-related and allied enterprises, including tourism ministers and officials from international organizations, such as the United Nations World Tourism Organization (UNTWO);

WHEREAS, the PROCURING ENTITY is in need of land travel management services to provide the vehicle requirements of the WTTC Technical Consultants and staff during the Summit's pre-event until their departure from 18 to 26 April 2022;

WHEREAS, the SUPPLIER has submitted its bid for the Procurement of Land Travel Management Services for the Summit;

WHEREAS, after the evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through BAC Resolution No. 2022- 1 has declared the SUPPLIER to be the bidder with the Single Calculated and Responsive Bid (SCRB) and has recommended the award of the contract in the total amount of Five Hundred Twenty-Six Thousand Eight Hundred Forty-Five Philippine Pesos (PhP526,845.00), inclusive of applicable taxes;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications or Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the PROCURING ENTITY's bid evaluation;
 - d. Performance Security;
 - e. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
- In consideration for the sum of Five Hundred Twenty-Six Thousand Eight Hundred Forty-Five Philippine Pesos (PhP526,845.00), inclusive of applicable taxes; or such other sums as may be ascertained, the SUPPLIER agrees to provide event management services in accordance with its Bid.
- 4. The PROCURING ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. The parties shall be entitled to sign and transmit this Agreement with an electronic signature whether by facsimile, email, or other electronic means, which signature shall be binding on the Party whose name is contained therein. Any Party providing an electronic signature agrees to promptly execute and deliver to the other parties an original signed Agreement upon request.
