Description

I. BACKGROUND

The APEC is a regional economic forum established in 1989 to leverage the growing interdependence of the Asia-Pacific. APEC's 21 members aim to create greater prosperity for the people of the region by promoting balanced, inclusive, sustainable, innovative and secure growth and by accelerating regional economic integration.

The Ministry of Tourism and Sports, Thailand will host the 60th APEC Asia Pacific Economic Cooperation (APEC) Tourism Working Group (TWG) Meeting and 11th APEC Tourism Ministerial Meeting 14 to 20 August 2022 (inclusive of travel dates) in Bangkok, Thailand. Thailand, as the APEC host for this year, will focus on charting a post-COVID-19 future for the Asia-Pacific region. The theme for APEC 2022 is "Open. Connect. Balance." The APEC host economy is responsible for chairing the annual Economic Leaders' Meeting, selected ministerial meetings, and senior officials including the following meeting:

- 1. 60th APEC TWG Meeting aims to foster economic development in the Asia-Pacific region through sustainable and inclusive tourism. Further, it also recognizes that tourism is one of the region's fastest growing industries and important vehicles for economic development among the APEC economies;
- 2. 11th APEC TMM anticipated to be a significant venue for APEC Tourism Ministers to discuss cooperation in the tourism sector, exchange views, and share information in order to support the revitalization of regional tourism and establish the new tourism direction for the post-COVID-19 era.

On the sidelines of the APEC Meetings, the Philippine Department of Tourism (PDOT) will organize a Meeting with Thai

Tourism Stakeholders and a High-Level Bilateral Meeting between Philippines and Thailand.

In this regard, the PDOT is in need of a DOT-Accredited Travel and Tour Operator based in Metro Manila to provide requirements on international airfare, meals, ground transportation, travel insurance, and tokens in connection with the conduct and participation of PDOT officials and personnel on the aforementioned meetings.
