Procurement of Travel and Tour Operator ASEAN Gender and Development in Tourism Program 21 November 2022 I Metro Manila, Philippines

I. PROJECT DESCRIPTION

The Department of Tourism (DOT) requires a competent, experienced and DOT-accredited travel and tour operator that can provide meals and transportation on 21 November 2022 in Metro Manila, Philippines (venue to be announced).

II. BACKGROUND

The Philippine Department of Tourism (PDOT) is the lead country coordinator for ASEAN Gender and Development. As we enjoin to celebrate the 18-day campaign to end violence against women, the PDOT will host a one-day forum on 21 November 2022, Monday in Metro Manila, Philippines (venue to be announced).

The celebration aims to prevent and eliminate violence against women and girls (VAWG) worldwide. Also, the forum will highlight the impact of combining individual effort towards a collaborative thrust to attain a VAW-free tourism industry. As we fight all gender-related issue, the PDOT looks forward to gain insight and share best practices and experiences in understanding women empowerment, VAWC, VAWG, and GAD.

III. OBJECTIVES

- o Meals include local Filipino cuisine and delicacies
- o Buffet lunch includes appetizer, 5 main courses (vegetable, pork, beef or chicken, and fish), steamed rice, 1 round of drink (soda or canned juice), dessert
- o Provision of free-flowing coffee and tea
- 2. Transportation Service
- i. Provision of at least 18-seater van for the DOT secretariat on 21 November 2022
- ii. Whole day usage of van, at least 10 hours
- iii. Transport service is inclusive of driver, driver's meal, and other vehicular fees and charges.
