



REQUEST FOR EXPRESSION OF INTEREST FOR THE

***Procurement of Consultancy Services on the Design,
Development and Production of Promotional
Materials for the Green Corridor Initiative (GCI)
Phase One Tourism Circuits***

1. The *Department of Tourism (DOT) Region IV – A CALABARZON*, through the *General Appropriations Act (GAA) Continuing Fund FY 2021* intends to apply the sum of **Three Million Five Hundred Thousand Pesos (Php 3,500,000.00) inclusive of applicable taxes**, being the Approved Budget for the Contract (ABC) to payments under the contract for **DOT-BAC-REI No. 2022-001**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *DOT* now calls for the submission of eligibility documents for the ***Procurement of Consultancy Services on the Design, Development and Production of Promotional Materials for the Green Corridor Initiative (GCI) Phase One Tourism Circuits***. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **14 October 2022 until 9:00 a.m. only at the Department of Tourism Region IV – A, G/F Dencris Business Building, National Highway, Barangay Halang, Calamba City Laguna 4027**. **Eligibility Check will be on the same day, October 14, 2022 to be held at the Department of Tourism Region IV – A Conference Room, G/F Dencris Business Building, National Highway, Barangay Halang, Calamba City Laguna 4027 at 10:00 a.m., simultaneously thru Zoom (virtual platform)**. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from *DOT* and inspect the Bidding Documents at the address given below during **8:00 a.m. to 5:00 p.m.**
4. A complete set of Bidding Documents may be acquired by interested bidders on **October 6 – 13, 2022 (8:00 a.m. to 5:00 p.m.) from the address below**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of **five (5)** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- *Applicable experience of the consultant and members in case of joint ventures, considering both the overall experiences of the firms or, in the case of new firms, the individual experiences of the principal and key staff, including the times when employed by other consultants (60%);*
- *Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking (20%); and*
- *Current workload relative to capacity (20%);*

Passing Rate: 80%

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

7. The Procuring Entity shall evaluate bids using the *Quality Based Evaluation (QBE)* procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
8. The contract shall be for four (4) months from the receipt of the Consultant of the Notice to Proceed;
9. The *DOT Region IV-A* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
