

**INVITATION TO BID (IB)**

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

- Name of Project: 2017 Annual Physical Examination (APE) Program for all DOT Officials and Employees (Permanent / Job Order personnel)
- Brief description of the Project: To uphold and promote employees' health and well-being to ensure maximum efficiency and productivity in the workplace
- Approved Budget for the Contract: Three Million Four Hundred Eighty Thousand Philippine Pesos (PhP3,480,000.00) inclusive of all applicable taxes
- Contract Duration: November to December 2017

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding.
