



INVITATION TO BID (IB)

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

- Name of Project:** Familiarization Tour for Turkish Agents
- Brief description of the Project:** Services of a local tour operator in the Philippines engaged in the business of providing tour packages
