

**Contract for the Procurement of Consulting Services for Local and International Events Marketing Communication**

This Contract for the Procurement of Consulting Services for Local and International Events Marketing Communication ("Agreement") is made and entered into this 09<sup>th</sup> day of December 2023 by and between:

and

**CTV CORPORATE TELEVISION INC.**, a private entity with business address at Penthouse Bloomingdale Bldg., 205 Salcedo st., Makati City, represented by its **President, KRISTIAN V. DAVID** ("Consultant");

Each a "Party" and collectively, the "Parties"

**WITNESSETH:**

  - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.
