**Contract for the Procurement of Consulting Services for the Promotions of Philippine Islands, Award-Winning Philippine Destinations and Tourism Products**

This *Contract for the Procurement of Consulting Services for the Promotions of Philippine Islands, Award-Winning Philippine Destinations, and Tourism Products* ("Agreement") is made and entered into this 2<sup>nd</sup> day of December 2023 by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by **Officer-In-Charge, MAE ELAINE T. BATHAN** ("Procuring Entity");

and

**UNIVERSAL VISION SOLUTION COMMUNICATIONS INC.**, a private entity with business address at 1819B Concepcion St., Brgy. Valenzuela, Makati City, represented by its **Chief Executive Officer, BENEDICT R. YALUNG** ("Consultant");

Each a "Party" and collectively, the "Parties"

**WITNESSETH:**

**WHEREAS**, the Procuring Entity is desirous that the Consultant execute the *Contract for the Procurement of Consulting Services for the Promotions of Philippine Islands, Award-Winning Philippine Destinations, and Tourism Products (DOT-SBAC-REI No. 2023-031)* (hereinafter called "the Works") and the Procuring Entity has accepted the bid for **Seventy-Four Million Five Hundred Thousand Pesos (Php74,500,000.00)**, inclusive of all applicable taxes, agency service fees, bank charges, travel fees, talent fees and other fees as may be incurred in the process, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

**NOW, THEREFORE**, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, to wit.:

  - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;

- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.

3. In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
