Contract for the Procurement of Consulting Services for the Development of Road Map and Action Plan for the Surf Tourism in the Philippines

This *Contract for the Procurement of Consulting Services for the Development of Road Map and Action Plan for the Surf Tourism in the Philippines* ("Agreement") is made this **SEP 25 2023**, 2023, in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Senator Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY VERNA COVAR-BUENSUCESO** ("Procuring Entity");

and

CERTEZA INFOSYS CORP, a private entity with business address at Units 202, 204-206 VAG Building, Ortigas Avenue, Greenhills, San Juan City, Metro Manila, represented herein by its Executive Vice President for Consultancy **MS. ANGELA R. TIANGCO**, in joint venture with **TECHNOEARTH SYSTEMS CORPORATION**, a private entity with business address at Room 303 ALCCO Building, Ortigas Avenue Greenhills, San Juan City, Manila, represented by its Treasurer **MR. RAUL JOSEPH E. DE GUZMAN** (collectively, the "Consultant");

WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute the *Contract for the Procurement of Consulting Services for the Development of Road Map and Action Plan for the Surf Tourism in the Philippines/DOT-BAC-REI No. 2023-014* (hereinafter called 'the Works') and the Procuring Entity has accepted the bid for **Six Million Pesos (PhP6,000,000.00)**, inclusive of applicable taxes by the consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a. General and Special Conditions of Contract,
 - b. Terms of Reference;
 - c. Request for Expression of Interest;
 - d. Instructions to Bidders;
 - e. Bid Data Sheet;
 - f. Addenda and/or Supplemental/Bid Bulletins, if any;
 - g. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - h. Eligibility requirements, documents and/or statements;
 - i. Performance Security;
 - j. Notice of Award of Contract and the Bidder's conforme thereto;
 - k. Other contract documents that may be required by existing laws and/or the Procuring Entity.

3. In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


