# Contract for the Procurement of Consulting Services for the Development of Road Map and Action Plan for the Surf Tourism in the Philippines

RAUL JOSEPH E. DE GUZMAN (collectively, the "Consultant");

#### WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute the Contract for the Procurement of Consulting Services for the Development of Road Map and Action Plan for the Surf Tourism in the Philippines/DOT-BAC-REI No. 2023-014 (hereinafter called 'the Works') and the Procuring Entity has accepted the bid for Six Million Pesos (PhP6,000,000.00), inclusive of applicable taxes by the consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

  - h. Eligibility requirements, documents and/or statements;
  - i. Performance Security;
  - j. Notice of Award of Contract and the Bidder's conforme thereto;
  - k. Other contract documents that may be required by existing laws and/or the Procuring Entity.

- 4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
