

**Contract for the Procurement of Services of a Consultancy Company for DOT-NCR's
Services on Marketing and IT Support and Solutions for the Philippines Hop-On and Hop-Off
Phase 2**

This *Contract for the Procurement of Consultancy Services of Services on Marketing and IT Support and Solutions for the Philippines Hop-On and Hop-Off Phase 2* ("Agreement") is made this 03 JAN 2024, in the City of Makati, by and between:

The DEPARTMENT OF TOURISM – NATIONAL CAPITAL REGION (DOT-NCR), a government agency with principal office address at the New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, Philippines 1200, represented by Director **SHARLENE ZABALA-BATIN**, of legal age, Filipino and hereinafter referred to as "**Procuring Entity**";

and

POSITIVE EXPOSURE PRODUCTIONS, INC., is a private entity existing and duly registered under the laws of the Philippines, with address at Unit 909 Tycoon Corporate Centre, Pearl Drive, Barangay San Antonio, Pasig City, herein represented by its CEO **MARINEL BARQUIN LEE**, referred to as the "**Consultant**";

WITNESSETH:

WHEREAS, the Procuring Entity is desirous that the Consultant execute *Contract for the Procurement of Services of a Consultancy Company for DOT-NCR's Services on Marketing and IT Support and Solutions for the Philippines Hop-On and Hop-Off Phase 2 (DOT-NCR REI No. 2023-11-003)* (hereinafter called "the Works") and the Entity has accepted the bid for **Seven Million Six Hundred Eighty-Six Thousand Three Hundred Twenty Eighty Pesos (PhP7,686,328.00)**, inclusive of all applicable taxes, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:



1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a. General and Special Conditions of Contract;
 - b. Terms of Reference;
 - c. Request for Expression of Interest;
 - d. Instructions to Bidders;
 - e. Bid Data Sheet;
 - f. Addenda and/or Supplemental/Bid Bulletins, if any;
 - g. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - h. Eligibility requirements, documents and/or statements;
 - i. Performance Security;
 - j. Notice of Award of Contract and the Bidder's conforme thereto; and

- k. Other contract documents that may be required by existing laws and/or the Procuring Entity.
- 3. In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the provisions of this Agreement and remedy any defects therein in conformity with the provisions of this Agreement.
- 4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of this Agreement, the Contract Price or such other sum as may become payable under the provisions of this Agreement at the times and in the manner prescribed by this Agreement.
