

**Contract for the Procurement of Consulting Services for Film Tourism**

This *Contract for the Procurement of Consulting Services for Film Tourism* ("Agreement") is made and entered into this 22 day of January 2024 by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by **Assistant Secretary, GISSELA MARIE R. QUISUMBING** ("Procuring Entity");

and

**UBUNTU PREMIUM STUDIOS, INC.**, a private entity with business address at 40 M Miranda, Santa Lucia, San Juan City, represented by its **Chief Operating Officer, GERARD RAYMUND L. ESTRELLA** ("Consultant");

Each a "Party" and collectively, the "Parties"

**WITNESSETH:**

**WHEREAS**, the Procuring Entity is desirous that the Consultant execute the *Contract for the Procurement of Consulting Services for Film Tourism (DOT-SBAC-REI No. 2023-033)* (hereinafter called "the Works") and the Procuring Entity has accepted the bid for **Fourteen Million Seven Hundred Seven Thousand Five Hundred Eighty-Nine Pesos and 60/100 (Php14,707,589.60)**, inclusive of all applicable taxes, fees, and other charges, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.
