BAC Resolution Recommending the Use of Negotiated Procurement-Small Value Procurement as an Alternative Method of Procurement, Declaring the Single Calculated and Responsive Quotation and Recommending Award to Nicatto Events and Marketing Dynamics Corporation for the Event Management in Celebration of Fiesta Hispano-Filipino (Night of Cultural Presentations) in connection to the Fiesta de Intramuros

WHEREAS, the Department of Tourism National Capital Region (DOT NCR) through the General Services/Procurement Unit, posted the Request for Quotation (RFQ) for Event Management for the Celebration of Fiesta Hispano-Filipino (Night of Cultural Presentations) in connection to the Fiesta de Intramuros in PhilGEPS and DOT website continuously for at least three (3) calendar days, starting on 30 August 2024, and the deadline for the submission of quotations was set on 04 September 2024. And a copy of PhilGEPS and DOT Website posting is hereto attached, and made an integral part hereof;

WHEREAS, the Approved Budget for the Contract (ABC) is **Pesos: Three Hundred Thousand only (Php 300,000.00):**

WHEREAS, three (3) known service providers were invited to join by sending Request for Quotation (RFQ) via e-mail and to submit their quotation via personal service and or through courier, in compliance with the procedure on Negotiated Procurement - Small Value Procurement pursuant to Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184);

WHEREAS, in response to the said posting and invitation, only one (1) prospective bidder submitted its quotation within the set deadline for the submission of quotations on 04 September 2024, to wit:

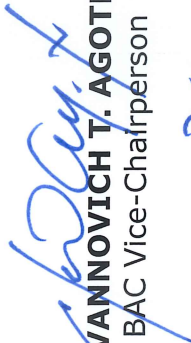

- b) To declare **Nicatto Events and Marketing Dynamics Corporation**, as the **Single Calculated and Responsive Quotation** and to award the contract for Event Management in Celebration of Fiesta Hispano-Filipino (Night of Cultural Presentations) in connection to the Fiesta de Intramuros in the amount of Pesos: **Three Hundred Thousand only (Php 300,000.00)**, inclusive of all applicable taxes.
