



**BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB)
and Recommending Award for the Procurement for the Enhancement of
Human Resource Information System (HRIS)
DOT-BAC IB NO. 2024-017**

Resolution No. 2024 - 145

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement for the Enhancement of Human Resource Information System (HRIS)**, in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least twenty-one (21) calendar days, starting on 04 May 2024. The total Approved Budget for the Contract (ABC) of **Fifteen Million Eight Hundred Thirty-Three Thousand Six Hundred Twenty-Three Pesos and 33/100 (PhP15,833,623.33)** inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, a Pre-Bid Conference was held on 13 May 2024 which was attended by the following bidders:

1. EBIZOLUTIONS INC.
2. DOÑA ALEJANDRA INC.
3. SD PUBLICATIONS INC.

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. 1 announcing amendments and clarifications in the bidding documents. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex "B"** and made an integral part hereof;

WHEREAS, in response to said posting, **three (3)** interested bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 06 June 2024. Namely:

1. EBIZOLUTIONS INC.
2. DOÑA ALEJANDRA INC.
3. SD PUBLICATIONS INC.

WHEREAS, during the opening of bids held on 06 June 2024, all three (3) bidders were declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "C"**, and made an integral part hereof;

Upon careful examination, validation, and verification of the eligibility, technical, and financial requirements submitted by **DOÑA ALEJANDRA INC.**, its bid has been found to be "responsive" and complying with the Technical Specifications and other requirements provided in the Bidding Documents. A copy of the Post-Qualification Report is hereto attached, marked as **Annex "F"** and made integral parts hereof.

NOW, THEREFORE, foregoing premises considered, WE, the Members of the DOT Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved**:

- a) To declare **DOÑA ALEJANDRA INC.** as the **Lowest Calculated and Responsive Bid (LCRB)** for the **Procurement for the Enhancement of Human Resource Information System (HRIS) (DOT-BAC IB NO. 2024-017)** and award the contract in the total amount of **Fifteen Million Seven Hundred Ninety-Nine Thousand Six Hundred Twenty-Seven Pesos and 18/100 (PHP15,799,627.18)**, inclusive of applicable taxes; and
- b) To recommend for approval of the Secretary of Tourism the foregoing findings.
