There is no need to submit attachments for the Statement of all its Ongoing Government and Private Contracts (Annex A), however during Post-qualification, DOT reserves the right to validate, verify, and ascertain all statements made in the said Statement. On the other hand, prospective bidders are required to attach the supporting documents required for the Single Largest and Completed Contracts (SLCC) (refer to Annex B of the Bidding Documents).
How much percentage is the administrative fee? What rate will be used with regard to the administrative cost?	2. We will follow the guidelines provided in the DOLE Order No. 18-A s.2011 which requires an administrative fee of not less than ten percent (10%) of the total contract cost.
