I. PROJECT/ ACTIVITY

- II. MINIMUM REQUIREMENTS:

- B. Must be accredited by the Philippine Government Electronic Procurement System;
- C. Tour Operators must be specialized in golf tourism for at least 2 years;

- E. Must have a certification from the International Association of Golf Tour Operators (IAGTO);
- F. Willing to provide services and willing to coordinate with indoor golf management;
- G. Ground arrangement (inclusive of transportation services and toll fees if applicable, full board meals and snacks, and indoor golf arrangement);
- H. Must be willing to provide services on a send bill arrangement.
- I. Bidders must submit their quotation with a cost breakdown to differentiate the amount of service fee and the amount to be earmarked for the payment to the third parties or other proprietors. Otherwise, tax withheld will be credited from the total contract price.
