BAC Resolution Recommending the Use of Negotiated Procurement-Small Value Procurement as an Alternative Method of Procurement, Declaring the Lowest Calculated and Responsive Quotation and Recommending Award to Spice Cuisine Food Services, Inc.

Resolution No. 2025-008

WHEREAS, the Department of Tourism National Capital Region (DOT NCR) Tourism Development Division (TDD) through the General Services/Procurement Unit, posted the Request for Quotation (RFQ) for Procurement of Catering Services for the conduct of Local Tourism Development Planning 2 (LTDP) for LGU’s Marikina, Las Pinas, Pasay and San Juan in the PhilGEPS website and DOT website continuously for at least three (3) calendar days, starting on 19 February 2025, and the deadline for the submission of quotations was set on 25 February 2025. A copy of the PhilGEPS and DOT Website posting is hereto attached, and made an integral part hereof;

WHEREAS, the Approved Budget for the Contract (ABC) is **Pesos: Ninety-Eight Thousand (Php 98,000.00)**:

WHEREAS, nine (9) known service providers were invited to join by sending Request for Quotation (RFQ) via e-mail and to submit their quotation via personal service and or through courier, in compliance with the procedure on Negotiated Procurement - Small Value Procurement pursuant to Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (R.A. 9184);

WHEREAS, in response to the said posting and invitation, two (2) prospective bidder submitted its quotation within the set deadline for the submission of quotations on 25 February 2025, to wit:

- a) To adopt Negotiated Procurement-Small Value Procurement under Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 for the Procurement of Catering Services for the conduct of Local Tourism Development Planning 2 (LTDP) for LGU's Marikina, Las Pinas, Pasay and San Juan;
- b) To declare One Star Enterprise, as the **Lowest Calculated and Responsive Quotation** and to award the contract for Procurement of Catering Services for the conduct of Local Tourism Development Planning 2 (LTDP) for LGU's Marikina, Las Pinas, Pasay and San Juan in the amount of Pesos: Ninety Thousand Three Hundred (Php 90,300.00), inclusive of all applicable taxes.
- c) To recommend for the approval of the Regional Director (Head of Procuring Entity) the foregoing findings.
