

Amending BAC Resolution No. 2024-175 (Declaring Single Calculated and Responsive Bid (SCRB) and Recommending Award for the Procurement of Fuel (Diesel/Gasoline) with a Fuel Card Technology/System for the Department of Tourism Motor Vehicle for CY 2025

WHEREAS, the Bids and Awards Committee (BAC) issued a resolution on 03 December 2024 declaring Petron Corporation as the Single Calculated and Responsive Bid (SCRB) for the Procurement of Fuel (Diesel/Gasoline) with a Fuel Card Technology/System for the Department of Tourism Motor Vehicle for CY 2025 in the amount of Four Million Two Hundred Forty-Eight Thousand Six Hundred Twenty-Five Pesos and 20/100 (PHP4,248,625.20) inclusive of applicable taxes and with a contract duration of twelve (12) months. A copy of BAC Resolution No. 2024-175 is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, on 26 December 2024, the Director of Administrative Service requested for a one (1) month extension of contract for the current provider of Fleet Card Services to ensure the continuity of the essential general support service provider pending the completion of the procurement process for the new service provider. The awarding of contract for the new service provider will be made only upon the approval and effectivity of the 2025 General Appropriations Act (GAA);

WHEREAS, to address this request, the BAC issued a resolution recommending a one (1) month extension of contract with Petron Corporation for the provision of fleet card services. A copy of BAC Resolution No. 2024-193 is hereto attached, marked as **Annex "B"**, and is made an integral part hereof;

NOW, THEREFORE, foregoing premises considered, WE, the Members of the DOT Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved** to recommend:

- a) To award the contract to Petron Corporation for the Procurement of Fuel (Diesel/Gasoline) with a Fuel Card Technology/System for the Department of Tourism Motor Vehicle for CY 2025, in the total amount of Three Million Eight Hundred Ninety-Five Thousand Seven Hundred Eighteen Pesos and 55/100 (PhP3,895,718.55) inclusive of all applicable taxes.
- b) For the Secretary of Tourism to approve the foregoing findings.

BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB) and Recommending Award for the Procurement of Fuel (Diesel/Gasoline) with a Fuel Card Technology/System for the Department of Tourism-Motor Vehicle for CY 2025 DOT-BAC IB 2024-031 (EPA)

WHEREAS, the Department of Tourism (DOT) – General Services Division, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Fuel (Diesel/Gasoline) with a Fuel Card Technology/System for the Department of Tourism-Motor Vehicle for CY 2025 (DOT-BAC IB 2024-031 (EPA)) in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least twenty-one (21) calendar days, starting on 09 October 2024. The total Approved Budget for the Contract (ABC) of Five Million Two Hundred Thirty-Seven Thousand Eight Hundred Pesos only (PhP5,237,800.00) inclusive of applicable taxes.

WHEREAS, a Pre-Bid Conference was held on 16 October 2024 and attended by **Petron** Corporation;

WHEREAS, pursuant to the said Pre-Bid Conference, the BAC issued Supplemental/Bid Bulletin No. 1 announcing clarifications and amendments to the Bidding Documents. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex "C"** and made an integral part hereof;

WHEREAS, in response to said posting, **Petron Corporation** was the only bidder who purchased the bidding documents and submitted their bid proposals within the deadline set on 12 November 2024;

WHEREAS, during the opening of bids held on 12 November 2024, **Petron Corporation** declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

WHEREAS, during Bid Evaluation, the BAC had the following findings:
