I. Clarifications:

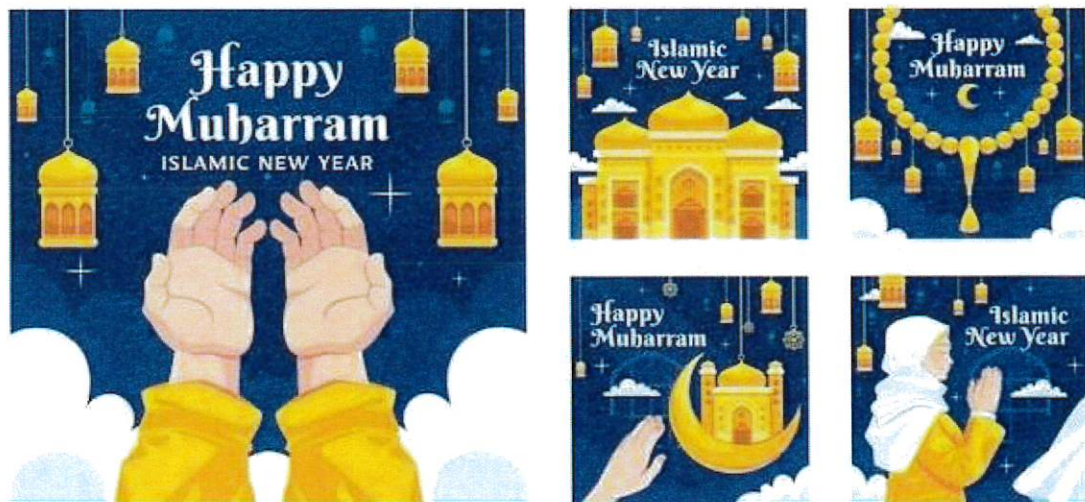
