## Description

The Philippine Financial and Inter-agency Pride (PFIP) Scholars will be visiting Metro Manila from April 22 to April 25, 2025. A key initiative during their visit is a curated Hop-On Hop-Off (HOHO) tour in Makati City, aimed at providing an immersive experience of the city's cultural and business districts. This initiative aligns with the Department of Tourism's (DOT) 'It All Starts Here' campaign, positioning Metro Manila as a prime destination.

The DOT has been actively promoting Metro Manila as a vibrant, inclusive, and diverse tourism hub. This HOHO initiative supports DOT's goal to enhance experiential tourism by highlighting the metropolis's unique cultural, business, and entertainment landscapes. The curated tour will showcase Metro Manila's modernity and heritage while emphasizing its inclusivity as a safe and welcoming space for all visitors, including members of the LGBTQIA+ community.

During a courtesy call with PFIP Executive Director Kaye Ko on January 9, 2025, DOT committed to sponsoring the HOHO tour tickets for the scholars. The DOT-NCR has been designated as the lead agency responsible for scheduling and curating the tour experience. This initiative also strengthens the development of Pink Tourism, reinforcing Metro Manila as a progressive and inclusive destination for LGBTQIA+ travelers and supporting DOT's broader efforts in establishing Pink Tourism as a niche market.

Pink Tourism, also known as LGBTQIA+ tourism, is a growing segment focusing on destinations, services, and

experiences that cater to the LGBTQIA+ community. The DOT NCR has been actively integrating inclusivity and diversity in its tourism programs, recognizing the economic and cultural contributions of LGBTQIA+ travelers. By hosting the HOHO tour for PFIP scholars, the DOT NCR is fostering stronger partnerships with LGBTQIA+ organizations and advocating for safe, inclusive, and welcoming tourism environments across the country. Notably, the DOT has positioned the Philippines as one of Asia's most LGBTQIA+-friendly destinations and hosted the first-ever Tourism Pride Summit in September 2023.

The Hop-On Hop-Off (HOHO) Tour for the Philippine Financial and Inter-agency Pride (PFIP) Scholars aims to successfully conduct the event on April 25, 2025, ensuring full participation from all 35 PFIP scholars. Their attendance is essential as they represent future leaders and advocates within the LGBTQIA+ community, making this initiative an opportunity to immerse them in an inclusive tourism experience. The tour will provide them with firsthand exposure to Metro Manila's rich cultural and economic landscapes, strengthening their understanding of the city's role in advancing diversity and inclusion in the tourism industry.

In preparation for this, all necessary tour tickets and logistical arrangements must be secured by March 2025. Close coordination with the Department of Tourism - National Capital Region (DOT-NCR) and relevant stakeholders will be maintained to facilitate an organized, seamless, and engaging tour experience.
