V. BACKGROUND:

The OPMD-ESL conducted the first familiarization tour for Russian, Kazakhstani, and Kyrgyztani education agents on January 13-20, 2017 to take advantage of their interest to discover more Asian countries that offer affordable overseas education. Currently, Malaysia and Singapore are the most preferred study destinations among students from Russian and Commonwealth of Independent States (CIS) countries due to lower cost, accessibility, safety, and security. The activity has enabled the agents to gain information on the schools' facilities, curriculum, cost, quality of teachers, and fun activities necessary in designating tour packages suitable for Russian students.

VI. PURPOSE/OBJECTIVES:

The familiarization tour aims to expand the network of Russia agents selling Philippine ESL. It is also expected to sustain the popularity of the Philippines as an alternative study destination among the Russian market.

In addition to the education component, the familiarization tour aims to highlight the attractions and fun components

to further convince the agents to consider the Philippines as an educational destination for their students.
