DESCRIPTION

The Office of Product and Market Development (OPMD) – Dive is in need of the services of a competent PR Agency to handle print and social media publicity featuring the following projects for a period of three months (April to June):

- Laurent Ballesta Philippine Expedition (April 2018)
- Objectif Atlantide Underwater Investigation (May 2018)
- Thailand Dive Expo (May 2018)
- DOT Dive Travel Mart at the DRT Show Philippines (September 2018)
- Anilao Underwater Shootout (November 2018)

OBJECTIVES

- 1. To highlight the rich marine biodiversity in the Philippines' destinations
- 2. To heighten awareness on the Philippines' initiatives to promote sustainable tourism
- 3. To partner with high-profile personalities in the global dive industry who can act as "Dive Ambassadors" of the Philippines

MINIMUM REQUIREMENTS

- A. Must be a Philippine organization capable of providing the following services:
- a. PR Management;

- b. Social Media Management;
- B. Must have at least 3 years of experience in crafting publicity plans for medium to large scale events;
- C. Must have at least one team member familiar with the Philippine dive tourism industry, preferably an experienced scuba diver or freediver;
- D. Must be accredited with the Philippine Government Electronic Procurement Systems (PhilGEPS); and
- E. Must be willing to provide services on a send-bill arrangement.

D. Manage Dive Philippines social networking sites from April to June (Facebook and Instagram)

□ Daily feeds to social networking sites (infographics, shared posts, and milestones related to Dive Philippines);

☐ Create thematic posts for event sustaining activities;

E. Create awareness and generate online traffic for Dive Philippines social networking sites through interactive and engaging posts and boosted/sponsored posts;

F. Coordinate with relevant media for interview requests and other media-related concerns;

G. Monitor releases, publications, and airings, as applicable;

H. Compile all international and local exposures made on Dive Philippines on a monthly basis; and

I. Generate report on final media reach, values, and mileage for the three-month retainer period.
