TERMS OF REFERENCE Venue Requirement

Background

The development of the Philippine MICE Industry Roadmap is a project initiated by the Philippine Association of Convention/ Exhibition Organizers and Suppliers Inc. (PACEOS), in partnership with the Department of Tourism (DOT), and the Department of Trade and Industry-Board of Investments (DTI-BOI).

Recognizing MICE as one of the priority products as identified in the National Tourism Development Plan (2016 – 2022), the DOT together with DTI-BOI, and PACEOS have entered into a Memorandum of Agreement for the preparation and implementation of a Philippine MICE Industry Roadmap. Through the said MOA, the DOT has been requested to: (1) provide support through conceptualization, organization, and conduct of Focus Group Discussions/consultation; and (2) provide direction on the priority areas for tourism development to be included in the roadmap and for which MICE activities will be promoted.

During the first half of 2016, series of Focus Group Discussions were conducted and identified vital information on MICE industry's contribution to the economy, the status of MICE in the country, and ways of moving forward.

The MICE Roadmap was presented to the stakeholders from different fields, such as the trade and tourism industries, national government agencies, and mass media during the Trade and Industry Development (TID) Updates of the

DTI-BOI held in November 2017, and was subsequently launched last 18 January 2018.

To successfully achieve the targets of the roadmap, four sub-working groups needs to be created, to wit: (1) Policy and Governance; (2) Infrastructure; (3) Human Resource; and (4) Marketing. These sub-working groups shall be composed of government agencies and private organizations working together in crafting specific action plans.

As a next step, the sub-working group needs to be convened to develop a work plan outlining specific action plans for their respective sub-working group. The following schedules were agreed for the 1st sub-working group meetings:
