II. BACKGROUND:

III. PURPOSE/OBJECTIVES

The Department of Tourism is in need of the services of a DOT-accredited local tour operator in the Philippines engaged in the business of providing tour packages or its components to handle and coordinate arrangements for the familiarization trip for Diplomats living in the Philippines. The project is aimed at attaining the following objectives:

• To position the Philippines as a top-of-mind choice for beach holidays and adventure travel that adheres to the safety protocols and health standards amidst and post COVID-19 pandemic;

- To jumpstart the travels of the diplomatic community within the Philippines and have the Ambassadors be the unofficial travel endorsers to their foreign nationals who live in the country and that it is safe and adheres to international safety standards. El Nido in Palawan is one of the companies that has successfully operated and continues to offer Bubble Packages in the time of this pandemic.
