THE AWARDING OF WINNING BIDDER FOR THE PROCUREMENT OF MEALS AND  
ROOM ACCOMMODATION RELATIVE TO THE CONDUCT OF CARRYING CAPACITY  
DEVELOPMENT WORKSHOP ON AUGUST 01-02,2023 IN DIPOLOG CITY, ZAMBOANGA  
DEL NORTE

WHEREAS, on 18 July 2023, the Department of Tourism – Regional Office 9, through its Supervising Tourism Operations Officer requested approval for the procurement of MEALS AND ROOM ACCOMMODATION RELATIVE TO THE CONDUCT OF CARRYING CAPACITY DEVELOPMENT WORKSHOP ON AUGUST 01-02,2023 IN DIPOLOG CITY, ZAMBOANGA DEL NORTE per Purchase Request No. DOTR9-PROC-2023-149 which the Chief Tourism Operations Officer of the Department of Tourism Regional Office 9 approved on the same date;

WHEREAS, the said procurement was posted in Philgeps on July 19, 2023;

WHEREAS, the Approved Budget for the Contract for the said procurement amounts to *Seventy-Four Thousand Pesos (Php 74,000.00)*;

WHEREAS, DOT 9 received duly accomplished Request for Quotation (RFQ) from one (1) qualified supplier and the same was completed on 24 July 2023;

WHEREAS, on 24 July 2023, DOT 9 BAC received all documents pertaining to said procurement and deliberated for the supplier with the single responsive bid;

WHEREAS, per careful examination and after deliberation of duly accomplished RFQs, DOT 9 BAC recommends to award the same to MISSIO DEI HOTEL for the said procurement as the same has the single responsive bid;

WHEREAS, the bid price of MISSIO DEI HOTEL amounts to *Seventy-Four Thousand Pesos (Php 74,000.00)*;

NOW, THEREFORE, foregoing premises considered, WE, the Members of the DOT 9 Bids and Awards Committee, hereby resolve, as it is hereby resolved:

- a) And to declare MISSIO DEI HOTEL as the winning bidder for the procurement of MEALS AND ROOM ACCOMMODATION RELATIVE TO THE CONDUCT OF CARRYING CAPACITY DEVELOPMENT WORKSHOP ON AUGUST 01-02,2023 IN DIPOLOG CITY, ZAMBOANGA DEL NORTE as the same has the single responsive bid of *Seventy-Four Thousand Pesos (Php 74,000.00)*




