Service Contract

Supply and Delivery of Purified Drinking Water with Free Use of Hot and Cold Dispensers for the Department of Tourism for CY 2022

KNOW ALL MEN BY THESE PRESENTS:

That this Agreement, made and entered into this MAR 1 5 2022 in the City of Makati, Philippines, by and between

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, Philippines 1200 represented by OIC-Undersecretary for Tourism Regulation, Coordination, and Resource Generation, **ENGR. CHRISTOPHER V. MORALES**, of legal age, Filipino, hereinafter referred to as the "**FIRST PARTY**";

and

GOLDEN TIGER WATER REFILLING STATION (AQUABEST) is a private entity existing and duly registered under the laws of the Philippines, with office address at Commercial I Luneta Tower Condo Legarda Street, Sampaloc Manila and represented by its Owner, MICHAEL ANGELO HUSMILLO AYLLON, and hereinafter referred to as the "SECOND PARTY";

Each a Party, collectively, the "PARTIES."

WITNESSETH:

WHEREAS, the FIRST PARTY is the primary planning, programming, coordinating, implementing and regulatory government agency in the development and promotion of the tourism industry, both domestic and international;

WHEREAS, to ensure its officials, employees, and stakeholders' access to potable drinking water, the FIRST PARTY is in need of a Supplier to deliver its purified drinking water requirements for a period of twelve (12) months or from 16 March 2022 to 15 March 2023;

WHEREAS, the SECOND PARTY is a duly registered member of the Philippine Government Electronic Procurement System (PhilGEPS) who possesses the necessary skills, experience and expertise in providing the required services, has offered to undertake the project;

WHEREAS, the requirement was processed in compliance with the procedure on Negotiated Procurement-Small Value Procurement, pursuant to Section 53.9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act);

WHEREAS, the Bids and Awards Committee (BAC) of the DOT, through BAC Resolution No. 2022-021, has declared the SECOND PARTY to be the bidder with the Single Calculated and Responsive Bid (SCRB) as its quotation is found to be compliant and responsive to the specifications indicated in the Terms of Reference (TOR);

NOW, THEREFORE, based on the foregoing, the PARTIES hereby agree as follows:

1. SERVICES. The SECOND PARTY shall provide the FIRST PARTY the following:

- a. Four thousand four hundred (4,400) bottles/containers of 5-gallons per bottle/container of purified drinking water on per order basis;
- b. Thirty-one (31) units of hot and cold water dispenser, free of charge:
- c. Maintain one hundred (100) containers/bottles of purified drinking water per week;
- d. Submission of passed/approved Laboratory Analysis Result (Physical/Chemical Analysis and Bacteriological Analysis) issued by the third-party water-testing facility accredited by the Department of Health (DOH);
- e. Ensure that the container/bottles provided are free of dirt and contaminants;
- Immediately replace defective containers and water dispensers at no cost to the FIRST PARTY within 48 hours from the time it was reported and requested;
- g. Conduct monthly cleaning/washing/sanitizing, and proper maintenance of all the water dispensers at no-cost for optimum operation.

Details of the above including the other responsibilities of the **SECOND PARTY** are indicated in the attached **Terms of Reference**, which forms an integral part of this contract.

- 2. EFFECTIVITY AND TERM. This Agreement shall be effective for a period of twelve (12) months starting 16 March 2022 until 15 March 2023.
- COMPENSATION. By way of compensation for its services, the FIRST PARTY shall pay the SECOND PARTY the total amount indicated in the Statement of Account, which shall be based on actual expenses incurred, but not to exceed One Hundred Fifty-Four Thousand Pesos (PhP154,000.00), for the total actual cost of services rendered inclusive of VAT and other taxes.
- 4. PAYMENT. The above consideration will be paid by the FIRST PARTY after presentation of the required Statement of Account and other necessary documents, subject to the usual accounting and auditing rules and regulations by the SECOND PARTY. It is understood, however, that payment shall only be made after it has fully and satisfactorily rendered its undertaking under this agreement.
- 5. LIQUIDATED DAMAGES. When the SECOND PARTY fails to satisfactorily deliver any or all of the Goods and/or to perform the Services within the period(s) specified in this Agreement inclusive of duly granted time extensions if any, the FIRST PARTY shall, without prejudice to its other remedies under this Agreement and under the applicable law, deduct from the contract price, as liquidated damages, the applicable rate of one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay until actual delivery or performance. The FIRST PARTY need not prove that it has incurred actual damages to be entitled to liquidated damages. Once the amount of liquidated damages reaches ten percent (10%) of the total contract price, the FIRST PARTY may rescind or terminate the Agreement, without prejudice to other courses of action and remedies open to it.
- 6. FREE AND HARMLESS. The SECOND PARTY shall hold the FIRST PARTY free and harmless from, and hereby binds and obligates itself to indemnify the FIRST PARTY for any and all liabilities, losses, damages, injuries, including death, claims, demands, suits, proceeding, judgements, awards, fines, penalties and all expenses, legal or otherwise of whatever kind or nature arising from and by reason of this Agreement, due to the fault, negligence, act, act omission, delays, conduct, breach of trust, or non-observance or violation of this Agreement, or any of its stipulation and warranties by the SECOND PARTY and/or any of its employees, agents, representatives, or sub-contractors.
- DISPUTE RESOLUTION. If any dispute shall arise between the FIRST PARTY and the SECOND PARTY in connection with this Agreement, the Parties shall make every effort to resolve such dispute amicably. Should such dispute not be resolved, the same will be referred

for arbitration in accordance with RA No. 876 or the Arbitration Law and RA No. 9285 or the Alternative Dispute Resolution Act of 2004.

- 8. ELECTRONIC SIGNATURES. The parties shall be entitled to sign and transmit this Agreement with an electronic signature whether by facsimile, e-mail, or other electronic means, which signature shall be binding on the Party whose name is contained therein. Any Party providing an electronic signature agrees to promptly execute and deliver to the other parties an original signed Agreement upon request
- COMPLETENESS OF AGREEMENT. This Agreement, along with the select provisions in the
 annexes made integral parts hereof, contains the complete understanding of the Parties and
 may not be modified or amended except through another Agreement in writing duly executed by
 the parties.
