



BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB) and Recommending Award for the Procurement of Ground Handling Services for the Conduct of Dive Guides/Dive Masters Training Program in Negros Oriental on 18-25 November 2022

(DOT-BAC IB No. 2022-011)

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Ground Handling Services for the Conduct of Dive Guides/Dive Masters Training Program in Negros Oriental on 18-25 November 2022 (DOT-BAC IB No. 2022-011) in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least seven (7) calendar days, starting on 24 September 2022. The total Approved Budget for the Contract (ABC) of One Million Four Hundred Ninety-Five Thousand Philippine Pesos (PHP1,495,000.00) inclusive of applicable taxes.

WHEREAS, a Pre-Bid Conference was held on 03 October 2022 and attended by CCT. 168 TRAVEL AND TOURS CORP.

**WHEREAS**, in response to said posting, **CCT. 168 TRAVEL AND TOURS CORP.** was the only interested bidder who purchased the bidding documents and submitted their bid proposal within the deadline set on 17 October 2022;
