

## BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending Award for the Procurement of Tour Operator Services for the Vietnamese Trade Familiarization Trip in February 26 to March 02, 2023 (DOT-BAC IB No. 2022-021)

Resolution No. 2023 - 001

WHEREAS, the Department of Tourism (DOT) - Office of Product and Market Development, through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Tour Operator Services for the Vietnamese Trade Familiarization Trip in February 26 to March 02, 2023 (DOT-BAC IB No. 2022-021) in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least twenty-one (21) calendar days, starting on 24 November 2022. The total Approved Budget for the Contract (ABC) of One Million Two Hundred Thousand Pesos (PHP1,200,000.00) inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as Annex "A", and made an integral part hereof;

**WHEREAS**, a Pre-Bid Conference was held on 02 December 2022 and attended by two (2) interested bidders. Namely:

- 1. CCT 168. TRAVEL AND TOURS CORP.
- 2. SHROFF INTERNATIONAL TRAVEL CARE INC.

**WHEREAS**, in response to said posting, two (2) interested bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 19 December 2022. Namely:

- 1. CCT 168. TRAVEL AND TOURS CORP.
- 2. SHROFF INTERNATIONAL TRAVEL CARE INC.

**WHEREAS**, a Notice of Postponement was issued last 12 December 2022 amending the procurement schedule. A copy of the Notice of Postponement No. 1 is hereto attached, marked as **Annex "B"**;
