



**BAC Resolution Declaring Single Rated and Responsive Bid (SRRB) and
Recommending Award for the Procurement of "Tourism Destination
Marketing Company for Vietnam"
(DOT-BAC-REI No. 2020-006)**

WHEREAS, pursuant to approved Department of Tourism (DOT) Bids and Awards Committee (BAC) Resolution No. 2020-123, dated 27 July 2020 **Golden Jade Trading Service Co., Ltd.,** being the Single Rated Bidder (SRB) "Procurement of "Tourism Destination Marketing Company for Vietnam" was invited for the Opening of the Financial Proposal and Negotiation on 06 August 2020 and 07 August 2020, respectively, pursuant to the Competitive Bidding Procedures – Quality-Based Evaluation (QBE) provisions of Republic Act No. 9184 (RA 9184) and its 2016 Implementing Rules and Regulations (IRR).
