

BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB) and Recommending Award for the Procurement of Memorabilia for PRAISE Awards (DOT-BAC IB No. 2020-009 2nd Posting)

Resolution No. 2020 - 224

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the Procurement of Memorabilia for PRAISE Awards in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least seven (7) calendar days, starting on 03 December 2020. The total Approved Budget for the Contract (ABC) is Seven Million Seventy Thousand Philippine Pesos (PhP7,070,000.00) inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as Annex "A", and made an integral part hereof;

WHEREAS, a Pre-Bid Conference was held on 10 December 2020 and was attended by a lone bidder, Sodexo Benefits and Rewards Services Philippines, Inc.;

WHEREAS, pursuant to the said Pre-Bid Conference, the BAC issued Supplemental/Bid Bulletin No. 1 announcing clarifications and amendments to the Bidding Documents. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as "Annex B", and made an integral part hereof;

WHEREAS, in response to said posting, only one (1) prospective bidder, Sodexo Benefits and Rewards Services Philippines, Inc., purchased the bidding documents and submitted its bid proposal within the deadline set on 22 December 2020;

WHEREAS, during the opening of bids held on 22 December 2020, the lone prospective bidder was declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as Annex "C", and made an integral part hereof;

WHEREAS, upon detailed evaluation of the bids, below are the findings:

Description

INVITATION TO BID FOR THE Procurement of Memorabilia for PRAISE Awards

- 1. The Department of Tourism (DOT), through the General Appropriation Act 2020 intends to apply the sum of Seven Million Seventy Thousand Philippine Pesos (PhP7,070,000.00) being the ABC to payments under the contract for "Procurement of Memorabilia for PRAISE Awards" (Project Identification No. DOT-BAC IB 2020-009 2nd Posting). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DOT now invites bids for the above Procurement Project. Delivery of the Goods is required by 10 calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

SUPPLEMENTAL/BID BULLETIN NO. 1

Procurement of Memorabilia for PRAISE Awards (DOT-BAC-IB 2020-009 - 2nd Bidding)

This Supplemental/Bid Bulletin No. 1 is issued to all prospective bidders to clarify, modify, and/or amend items in the Bidding Documents as discussed and agreed during the Pre-Bid Conference held on 10 December 2020 for the above-mentioned project.

- On the Net Financial Contracting Capacity (NFCC)
 - a. Pursuant to Section 23.1 (a)(viii) of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184) and the Bidding Documents. Section VIII. Checklist of Technical and Financial Documents, prospective bidders may submit a computation of the Net Financial Contracting Capacity (NFCC) or a committed Line of Credit from a Universal or Commercial Bank.

Should the bidder opt to submit a NFCC, the computation of which must be equal to the approved budget for the contract (ABC). On the other hand, if the prospective bidder opts to submit a committed Line of Credit from a Universal or Commercial Bank, in lieu of the NFCC, the same must be at least equal to ten percent (10%) of the ABC.

- b. The Committed Line of Credit from a Universal or Commercial Bank must be issued specifically for the project.
- II. On the Bidding Documents Fee -

A prospective bidder who has previously purchased the bidding documents during the first bidding will no longer be required to pay for the bidding document for purposes of participating in this second bidding.

III. On the Deduction of Applicable Taxes -

In case the prospective bidder is exempted from paying VAT or other applicable taxes on the goods delivered, the bidder should submit a Tax Exemption Certificate or an equivalent document issued by the Bureau of Internal Revenue (BIR) to show that tax is not applicable.

This Supplemental/Bid Bulletin No.1 shall form part of the Bidding Documents.
