



BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) for Lot Nos. 1 and 2, Single Calculated and Responsive Bid (SCRB) for Lot No. 3 and Recommending Award for the Supply and Delivery of ICT Equipment (DOT-BAC IB No. 2020-004)

Resolution No. 2020- 120

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Supply and Delivery of ICT Equipment** in the DOT website, the PhilGEPS website, and in a conspicuous place continuously starting 07 March 2020. The Approved Budget for the Contract is **Twenty-Seven Million Two Hundred Ninety-Two Thousand Three Hundred Ninety-Seven and 95/100 Pesos (PhP27,292,397.95)**, classified into three (3) lots, as follows:

WHEREAS, the Competitive Bidding Procedures for Goods pursuant to the provisions of Republic Act No. 9184 (RA 9184) and its Implementing Rules and Regulations (IRR) was undertaken for purposes of this project;

WHEREAS, on 15 March 2020, the BAC issued Supplemental/Bid Bulletin No. 1 announcing the updated schedule of procurement activities, in view of the suspension of work in government offices. A copy of Supplemental/Bid Bulletin No. 1 is hereto attached, marked as **Annex "B"**, and made an integral part hereof;

WHEREAS, on 17 March 2020, the BAC issued Supplemental/Bid Bulletin No. 2 announcing the postponement of the pre-bid conference in view of the suspension of work in government offices from 17 March to 13 April 2020. A copy of Supplemental/Bid Bulletin No. 2 is hereto attached, marked as **Annex "C"**, and made an integral part hereof;

WHEREAS, on 16 April 2020, the BAC issued the Notice of Virtual Pre-bid Conference in view of the conduct of Pre-bid conference through online/video conferencing. A copy of the said Notice is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

WHEREAS, a Virtual Pre-bid Conference was held on 20 April 2020 and was attended by the following bidders:

- 1. Advance Solutions, Inc.**
- 2. Beacon Solutions, Inc.**
- 3. Accent Microtechnologies, Inc.**

WHEREAS, on 22 April 2020, the BAC issued Supplemental/Bid Bulletin No. 3 announcing the postponement of the deadline of submission and opening of bids, in view of the extension of the Enhanced Community Quarantine (ECQ) in Luzon until 30 April 2020. A copy of Supplemental/Bid Bulletin No. 3 is hereto attached, marked as **Annex "E"**, and made an integral part hereof;

WHEREAS, on 30 April 2020, the BAC issued Supplemental/Bid Bulletin No. 4 announcing the postponement of the deadline of submission and opening of bids, in view of the extension of the Enhanced Community Quarantine (ECQ) in Metro Manila, Central, Luzon, CALABARZON and other high-risk provinces until 15 May 2020. A copy of Supplemental/Bid Bulletin No. 4 is hereto attached, marked as **Annex "F"**, and made an integral part hereof;

WHEREAS, on 18 May 2020, the BAC issued Supplemental/Bid Bulletin No. 5 announcing the postponement of the deadline of submission and opening of bids in view of the Modified Enhanced Community Quarantine (MECQ) being enforced in over the entire National Capital Region (NCR), Laguna and Cebu City from 16 to 31 May 2020. A copy of Supplemental/Bid Bulletin No. 5 is hereto attached, marked as **Annex "G"**, and made an integral part hereof;

WHEREAS, pursuant to the Pre-Bid Conference last 20 April 2020, the BAC issued Supplemental/Bid Bulletin Nos. 6 and 7 announcing clarifications and amendments to the Bidding Documents. A copy of Supplemental/Bid Bulletin Nos. 6 and 7 are hereto attached, marked as **Annex "H" and "I"**, and made integral parts hereof;

WHEREAS, in response to said posting, **Maximum Solutions Corp.** and **Beacon Solutions, Inc.** purchased the bidding documents and likewise submitted its bid and was declared "passed" during the Opening of Bids and Preliminary Examination of bids held on 17 June 2020. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "J"** and made an integral part hereof;

WHEREAS, the detailed evaluation of bid resulted in the following:

WHEREAS, upon careful examination, validation and verification of the eligibility, technical and financial requirements submitted by **Maximum Solutions Corp.**, the Lowest Calculated Bid (LCB) for Lot Nos. 1 and 2, its bid has been found to be "non-responsive" and non-complying with the Terms of Reference (TOR) and other requirements provided in the Bidding Documents, thus post-disqualified. A copy of the Bid Evaluation Report and Notice of Post-Disqualification are hereto attached, marked as **Annex "L" and "M"**, respectively, and made integral parts hereof;

WHEREAS, an evaluation of the bid submission of Beacon Solutions, Inc. was conducted as the 2nd Lowest Calculated Bid (2nd LCB) for Lot Nos. 1 and 2 and as the Single Calculated Bid (SCB) for Lot No. 3. Upon careful examination, validation and verification of the eligibility, technical and financial requirements submitted by Beacon Solutions, Inc., its bid has been found to be "responsive" and complying with the Terms of Reference (TOR) and other requirements provided in the Bidding Documents. A copy of the Bid Evaluation and Post-Qualification Report are hereto attached, marked as **Annex "N" and "O"**, respectively, and made integral parts hereof;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **Beacon Solutions, Inc.** as the **Lowest Calculated and Responsive Bid (LCRB)** for **Lot No. 1 - Desktop** and **Lot No. 2 - Laptop** and as the **Single Calculated and Responsive Bid (SCR)** for **Lot No. 3 - Mobile Devices** for the **Supply and Delivery of ICT Equipment** with a total contract amount of **Twenty-Six Million Six Hundred Seventy-Two Thousand One Hundred Twenty-Five and 90/100 Pesos (PhP26,672,125.90)**, inclusive of all applicable taxes, classified in accordance with the following schedule:
