



**BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB)
and Recommending Award for the Procurement of CCTV Systems for the
Department of Tourism
(DOT-BAC IB No. 2020-12)**

Resolution No. 2020 - 235

WHEREAS, the Department of Tourism (DOT), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the **Procurement of CCTV System for DOT** in the DOT website, the PhilGEPS website and in a conspicuous place at the premises of the DOT continuously for at least seven (7) calendar days, starting on 27 November 2020. The total Approved Budget for the Contract (ABC) of **Eleven Million One Hundred Sixty-Six Thousand Philippine Pesos (PhP11,166,000.00)** inclusive of applicable taxes. A copy of the PhilGEPS posting is hereto attached, marked as **Annex "A"**, and made an integral part hereof;

WHEREAS, a Pre-Bid Conference was held on 04 December 2020 and attended by the following interested bidders:

- 1) Gocom Systems and Solutions Corp.
- 2) Fastel Services Inc.
- 3) Philippine Environmental and Technological Systems and Services Inc.
- 4) DGL Veracity Systems
- 5) Lightnet Connect System
- 6) FWS Construction Development and Supply Inc.

WHEREAS, pursuant to the said Pre-Bid Conference, the BAC issued Supplemental/Bid Bulletin Nos. 1 & 2 announcing clarifications and amendments to the Bidding Documents. A copy of Supplemental/Bid Bulletin Nos. 1 & 2 is hereto attached, marked as **Annex "B"** and **Annex "C"** and made an integral part hereof;

WHEREAS, prior to the submission of bid proposals, a site inspection was conducted and was attended by the following interested bidders:

1. Fastel Services Inc.
2. Philippine Environmental and Technological Systems and Services Inc.
3. Facilities Protection Inc.
4. Gocom Systems and Solutions Corp.

WHEREAS, in response to said posting, two (2) prospective bidders purchased the bidding documents and submitted their bid proposals within the deadline set on 17 December 2020, to wit:

- 1) Gocom Systems and Solutions Corp.; and
- 2) Facilities Protection Inc.

WHEREAS, during the opening of bids held on 17 December 2020, the two (2) prospective bidders were declared "passed" during the preliminary examination of bids. A copy of the Abstract of Bids "as Read" is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

WHEREAS, during Bid Evaluation, the BAC had the following findings:

WHEREAS, upon careful examination, validation and verification of the eligibility, technical and financial requirements submitted by **Gocom Systems and Solutions Corp.**, the Single Calculated Bid (SCB), its bid has been found to be responsive and complying with the eligibility, technical, and financial requirements under the Bidding Documents, and considered Post-Qualified. NOW, THEREFORE, foregoing premises considered, WE, the Members of the DOT Bids and Awards Committee, hereby **Resolve**, as it is hereby **Resolved**:

- To declare **Gocom Systems and Solutions Corp.** as the **Single Calculated and Responsive Bid (SCRB)** for the **Procurement of CCTV Systems for the Department of Tourism** and award the contract in the total amount of **Eleven Million One Hundred Sixty Thousand Philippine Pesos (PhP 11,160,000.00)**, inclusive of applicable taxes; and
- To recommend for approval of the Secretary of Tourism the foregoing findings.
