CONTRACT FOR THE PROCUREMENT OF SECURITY SERVICES

This Contract for the Procurement of Security Services ("Agreement") is made this AUG 26 2020, 2020, in the City of Makati, by and among:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **ASSISTANT SECRETARY, LEILA MAGDA G. RIVERA**, ("PROCURING ENTITY");

and

AREMOS SECURITY AND INVESTIGATION AGENCY, a private entity duly organized and existing under the laws of the Philippines, with business address at 8 Paredes St. BF Homes, Holy Spirit, Quezon City, duly authorized and represented herein by its **MANAGER, MR. ANTONIO C. SOMERA** ("SUPPLIER");

WITNESSETH:

WHEREAS, under Republic Act No. 9593 or the Tourism Act of 2009, the PROCURING ENTITY is mandated to develop and administer a maintenance program for building, grounds, facilities equipment, repair, improvement and/or enhancement as well as security programs and measures;

WHEREAS, pursuant to this mandate, the PROCURING ENTITY intends to engage the services of a contract to provide security services over its premises;

WHEREAS, the SUPPLIER has submitted its bid for the Procurement of Security Services for the period of **01 September to 31 December 2020**;

WHEREAS, after the evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through **BAC Resolution No. 2020-128** has declared the SUPPLIER to be the bidder with the Lowest Calculated and Responsive Bid (LCRB) and has recommended the award of the contract in the total amount of **Three Million Six Hundred Fifty-Seven Thousand One Hundred Eighty-Five Philippine Pesos and 032/100 (Php3,657,185.032)**, inclusive of applicable taxes;

NOW, THEREFORE, based on the foregoing, the **PARTIES** hereby agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the General Conditions of the Contract;
 - e) the Special Conditions of the Contract;



- f) the Performance Security; and
- g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
