**Contract for the Procurement of a Tourism Destination Marketing Company for Indonesia**

This Contract for the Procurement of a Tourism Destination Marketing Company for Indonesia ("Agreement") is made this 28 December 2020, in the City of Makati, by and among:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Senator Gil Puyat Avenue, Makati City, Philippines, represented by its **ASSISTANT SECRETARY VERNA COVAR-BUENSUCESO** ("PROCURING ENTITY");

and

**PT. INTRAREPS**, a private entity with business address at Jl. Dr. Saharjo No. 96A, South Jakarta, 12960, Indonesia represented by its **DIRECTOR DAVID HARSAMTO** ("Consultant")

**WITNESSETH:**

**WHEREAS**, the Entity is mandated to be the primary planning, programming, coordinating, implementing, and regulatory government agency in the development and promotion of the tourism industry, both domestic and international;

**WHEREAS**, pursuant to its mandate, the Entity seeks to promote Philippine tourism in foreign jurisdictions where it does not operate a Foreign Office, such as Indonesia, through the services of a Tourism Destination Marketing Company;

**WHEREAS**, despite the travel and tourism restrictions brought about by the COVID-19 pandemic, the Entity seeks to continue the promotion of Philippine tourism in foreign markets following a top-of-mind awareness marketing strategy;


**WHEREAS**, the Bids and Awards Committee (BAC) of the Entity, through **BAC Resolution No. 2020-195** has declared the Consultant to be the Single Rated and Responsive Bidder (SRRB) following a competitive bidding procedure for the procurement of consultancy services for a Tourism Destination Marketing Company;

**WHEREAS**, pursuant to the abovementioned BAC Resolution, the Entity has accepted the bid of the Consultant for a monthly professional fee of **Eight Thousand US Dollars (USD8,000.00)** or a total contract price of **Thirty-Two Thousand US Dollars (USD32,000.00)** or its equivalent in Philippine Pesos<sup>1</sup> inclusive of all applicable taxes, with the contract duration of four (4) months from the issuance to the Consultant of the Notice to Proceed;

**NOW, THEREFORE**, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - a. General and Special Conditions of Contract,
  - b. Terms of Reference;

- c. Request for Expression of Interest;
  - d. Instructions to Bidders;
  - e. Bid Data Sheet;
  - f. Addenda and/or Supplemental/Bid Bulletins, if any;
  - g. Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - h. Eligibility requirements, documents and/or statements;
  - i. Performance Security;
  - j. Notice of Award of Contract and the Bidder's conforme thereto;
  - k. Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
