WHEREAS, the Bids and Awards Committee (BAC) of the Entity, through BAC Resolution No. 2020-192, has declared the Consultant to be the Highest Rated and Responsive Bidder (HRRB) following a competitive bidding procedure for the procurement of consulting services for the Local Media Plan and Placements for Tourism Branding with a contract duration of five (5) months effective from the receipt by the Consultant of the Notice to Proceed;

WHEREAS, pursuant to the abovementioned BAC Resolution, the Entity has accepted the bid of the Consultant for Fifty-Eight Million Five Hundred Seventy-Seven Thousand Seven Hundred Thirty-Five Pesos and 50/100 (PhP58,577,735.50), inclusive of all applicable taxes;
