**Contract for the Procurement of a CCTV System**

This *Contract for the Procurement of a CCTV System* ("AGREEMENT") made this 29 December 2020, in the City of Makati, by and among:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY, ATTY. REYNALDO L. CHING**, hereinafter referred to as the "ENTITY";

and

**GOCOM SYSTEMS AND SOLUTIONS CORPORATION** a private entity duly organized and existing under the laws of the Philippines, with business address at Unit 218 Cityland Pioneer, Pioneer St. Highway Hills, Mandaluyong, Manila duly authorized and represented herein by its **SALES DIRECTOR, GLENN PAUL P. CACANINDIN**, herein referred to as the "SUPPLIER";

**WITNESSETH:**

**WHEREAS**, under Republic Act No. 9593 or the Tourism Act of 2009, the ENTITY is mandated to improve and/or enhance its security programs and measures;

**WHEREAS**, pursuant to this mandate, the ENTITY seeks install a closed-circuit television (CCTV) System to enhance and support the security services in the premises;

**WHEREAS**, the ENTITY is in need of a service provider for the installation of a CCTV system;

**WHEREAS**, the SUPPLIER has submitted its bid for the procurement of CCTV System in the amount of **Eleven Million One Hundred Sixty Thousand Philippine Pesos (PhP 11,160,000.00)** inclusive of all applicable taxes ("Contract Price");

**WHEREAS**, after due evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through BAC Resolution No. 2020-235 has declared the SUPPLIER to be the Single Calculated and Responsive Bid (SCRB) and has recommended the award of the contract to the SUPPLIER for the installation of the CCTV System within thirty (30) calendar days from the SUPPLIER's receipt of the Notice to Proceed;

**NOW, THEREFORE**, based on the foregoing, the Parties agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement:
  - a) The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - b) the Schedule of Requirements;
  - c) the Technical Specifications or Terms of Reference;

- d) the General Conditions of Contract;
- e) the Special Conditions of Contract;
- f) the Performance Security; and
- g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


