WHEREAS, pursuant to the abovementioned BAC Resolution, the Entity has accepted the bid of the Consultant in the amount of Thirty-Four Million Nine Hundred Ninety-Seven Thousand Seven Hundred Sixty Pesos (PhP34,997,760.00), inclusive of all applicable taxes;
