## WITNESSETH:

WHEREAS, the Entity is mandated to be the primary planning, programming, coordinating, implementing, and regulatory government agency in the development and promotion of the tourism industry, both domestic and international;

WHEREAS, pursuant to this mandate, the Entity seeks to implement a domestic tourism marketing campaign through local media placements targeted at travelers from Visayas and Mindanao, focusing on Metro Cebu and Metro Davao;

WHEREAS, the Entity needs to engage the services of a consultant to formulate a local media plan and implement local media placements to promote domestic tourism and restore the confidence of Filipinos to travel once again;

WHEREAS, the Bids and Awards Committee (BAC) of the Entity, through BAC Resolution No. 2021-144, has declared the Consultant to be the Highest Rated and Responsive Bidder (HRRB) following a competitive bidding procedure for the procurement of consulting services of a Local Media Planning, Buying and Placements Agency for the Department of Tourism -Lot No. 2 (Media Planning, Buying and Placements Targeting Visayas and Mindanao) with a contract duration of five (5) months effective from the receipt by the Consultant of the Notice to Proceed:

  - (k) Other contract documents that may be required by existing laws and/or the Entity.
