WITNESSETH:

WHEREAS, the Procuring Entity is mandated to be the primary planning, programming, coordinating, implementing, and regulatory government agency in the development and promotion of the tourism industry, both domestic and international;

WHEREAS, pursuant to this mandate, the Procuring Entity aims to position the Philippines as the "more fun" travel destination even in the new normal with an added focus on health and safety;

WHEREAS, the Procuring Entity needs to engage the services of a consultant to craft a digital media plan to further strengthen the Philippines' digital presence in opportunity and emerging international markets, such as Western Europe, Russia and the CIS, the Middle East, the Mediterranean and Southeast Asia;

WHEREAS, the Bids and Awards Committee (BAC) of the Procuring Entity, through BAC Resolution No. 2021-198, has declared the Consultant to be the Single Rated and Responsive Bidder (SRRB) following a competitive bidding procedure for the procurement of consulting services for the Digital Media Planning and Placements for the Global Campaign of the Department of Tourism with a contract duration of three (3) months effective from the receipt of the Notice to Proceed;

WHEREAS, pursuant to the abovementioned BAC Resolution, the Procuring Entity has accepted the bid of the Consultant in the amount of Forty Million Pesos (PhP40,000,000.00), inclusive of all applicable taxes;
