WHEREAS, pursuant to its mandate, and in support of the efforts of the Procuring Entity to cope with this pandemic and help re-start travel in the Philippines, the Cruise Team of the Office of Product and Market Development, pivoted its programs to focus on the domestic market, among which is the crafting of the Domestic Cruise Tourism Development Plan;

**WHEREAS**, for this purpose, the Procuring Entity will be engaging the services of a market research and consulting agency to undertake this project;

WHEREAS, the Bids and Awards Committee (BAC) of the Procuring Entity, through BAC Resolution No. 2021-195 has declared the Consultant to be the Single Rated and Responsive Bidder (SRRB) following a competitive bidding procedure for the procurement of consultancy services for the Research Program on the Development of Domestic Cruise Tourism Program and Other Nautical Tourism Products;

WHEREAS, pursuant to the abovementioned BAC Resolution, the Entity has accepted the bid of the Consultant for a total contract price of Three Million Nine Hundred Thousand Pesos (PhP3,900,000.00) inclusive of all applicable taxes, for a period of three (3) months effective from the receipt by the Consultant of the Notice to Proceed;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:
