Contract for the Procurement of Consultancy Services on the Maintenance of the ISO 9001:2015 Quality Management System of the Department of Tourism for FY 2022

This *Contract for the Procurement of Consultancy Services on the Maintenance of the ISO 9001:2015 Quality Management System of the Department of Tourism for FY 2022* ("Agreement") is made and entered into this ____ day of MAR 30 2022 by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by its **OIC-UNDERSECRETARY, ENGR. CHRISTOPHER V. MORALES** ("Procuring Entity");

and

MACRO VISION CONSULTANCY, a private entity with business address at B2 L1 Emerald Street, Camella Homes, South Annex, San Pedro, Laguna represented by its **PRESIDENT, ENGR. MARGEL ALBANO-JAJURIE** ("Consultant");

Each a "Party" and collectively, the "Parties"

WITNESSETH:

WHEREAS, the Procuring Entity is directed to adopt a Quality Management System (QMS)-certifiable to ISO 9001 in the delivery of its priority government services, pursuant to Executive Order No. 605 series 2007 "Institutionalizing the Structure, Mechanisms, and Standards to implement the Government Quality Management Program";

WHEREAS, the Procuring Entity needs to engage the services of a consultancy firm to provide professional and technical consultancy services to ensure the long-term maintenance of its QMS in compliance with ISO 9001:2015 standards;

WHEREAS, the Bids and Awards Committee (BAC) of the Procuring Entity, through **BAC Resolution No. 2022-034**, has declared the Consultant to be the **Single Rated and Responsive Bidder (SRRB)** following a competitive bidding procedure for the procurement of consultancy services on the Maintenance of the ISO 9001:2015 Quality Management System of the Department of Tourism for FY 2022;

WHEREAS, pursuant to the abovementioned BAC Resolution, the Procuring Entity has accepted the bid of the Consultant in the amount of **Two Million Ninety-Four Thousand Eleven Pesos and 12/100 (PhP2,094,011.12)**, inclusive of all applicable taxes, with a contract duration effective from the receipt by the Consultant of the Notice to Proceed until 31 December 2022;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, to wit.:

- (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Procuring Entity.

3. In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


