Contract for the Procurement of a Tourism Destination Marketing Company for Vietnam

This Contract for the Procurement of a Tourism Destination Marketing Company for Vietnam ("Agreement") is made this 28 2022, in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Senator Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY VERNA COVAR-BUENSUCESO** ("Procuring Entity");

and

GOLDEN JADE TRADING SERVICE CO. LTD., a private entity with business address at 491/A5 No Trang Long, Ward 13, Binh Thanh District, Ho Chi Minh City, Vietnam represented by its DIRECTOR, MS. NGUYEN THI MAI THANH ("Consultant")

WITNESSETH:

WHEREAS, under Republic Act No. 9593 or the Tourism Act of 2009, the PROCURING ENTITY is mandated to provide an integrated market development program to attract people to visit the Philippines and enhance the prestige of the country and the Filipino people in the international community;

WHEREAS, in line with this mandate, the Procuring Entity seeks to promote Philippine tourism in Vietnam, a source market for development but without an existing DOT foreign office;

WHEREAS, to carry out the above objective, there is a need to procure the services of a Tourism Destination Marketing Company that will, among others, assist in the formulation of a market development strategy and action plan for the Philippines in Vietnam as well as the implementation of its marketing projects therein;

WHEREAS, the Bids and Awards Committee (BAC) of the Procuring Entity, through BAC Resolution No. 2022-311 has declared the Consultant to be the Highest Rated and Responsive Bidder (HRRB) following a competitive bidding procedure for the procurement of consultancy services for a Tourism Destination Marketing Company;

WHEREAS, pursuant to the abovementioned BAC Resolution, the Procuring Entity has awarded the contract to the Consultant for a monthly professional fee of Seven Thousand Five Hundred US Dollars (USD7,500.00) or a total contract price of Forty-Five Thousand US Dollars (USD45,00.00)¹ or its equivalent in Philippine Pesos, inclusive of all applicable taxes, for a period of six (6) months effective from the receipt by the Consultant of the Notice to Proceed;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - h. Eligibility requirements, documents and/or statements;
 - i. Performance Security;
 - j. Notice of Award of Contract and the Bidder's conforme thereto;
 - k. Other contract documents that may be required by existing laws and/or the Procuring Entity.
- 3. In consideration of the payments to be made by the Procuring Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
- 4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
