Contract for Ground Handling Services for the Conduct of Dive Guides/Dive Masters Training Program in Negros Oriental

This Contract for the Procurement of Ground Handling Services for the Conduct of Dive Guides/Dive Masters Training Program (Agreement) is made this NOV 07 2022 2022, in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY, VERNA C. BUENSUCESO** and hereinafter referred to as the "PROCURING ENTITY";

and

CCT. 168 TRAVEL AND TOURS CORP., a private entity duly organized and existing under the laws of the Philippines, with business address at Unit 501 The Richmond Plaza, 21 San Miguel Avenue Corner Lourdes St., Ortigas Center, Pasig City, Metro Manila, duly authorized and represented herein by its **GENERAL MANAGER, PLACIDA S. FAUSTINO** and herein referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, under Republic Act No. 9593 or the Tourism Act of 2009, the PROCURING ENTITY is mandated to provide an integrated market development program to attract people to visit the Philippines and enhance the prestige of the country and the Filipino people in the international community;

WHEREAS, pursuant to this mandate, the PROCURING ENTITY will conduct a Dive Master Training and Certification Program ("Program") that aims to provide an alternative livelihood source for underprivileged Filipinos in top and emerging dive destinations by providing them with internationally-recognized training that will enable them to advance professionally and find employment in the dive industry;

WHEREAS, the PROCURING ENTITY is in need of ground handling services to provide the required logistics and other arrangements for the Program on 18-25 November 2022 in Negros Oriental;

WHEREAS, the SUPPLIER has submitted its bid for the provision of the required services for the Program;

WHEREAS, after the evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through **BAC Resolution No. 2022-217** has declared the SUPPLIER to be the bidder with the Single Calculated and Responsive Bid (SCRB) and has recommended the award of the contract in the total amount of **One Million Two Hundred Forty-Nine Thousand Fifty Philippine Pesos (PHP1,249,050.00)**, inclusive of applicable taxes;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
- a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications or Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - d. Performance Security;
 - e. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
3. In consideration for the sum of **One Million Two Hundred Forty-Nine Thousand Fifty Philippine Pesos (PHP1,249,050.00)**, inclusive of applicable taxes; or such other sums as may be ascertained, CCT. 168 Travel and Tours Corp. agrees to provide ground handling services in accordance with its Bid.
4. The *Department of Tourism* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
