Contract for the Procurement of Security Services

This *Contract for the Procurement of Security Services* (Agreement) is made this April 26, 2023, in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **UNDERSECRETARY SHAHLIMAR HOFER TAMANO**, and hereinafter referred to as the "PROCURING ENTITY";

and

DBPSC SECURIY SERVICE INCORPORATED, a private entity duly organized and existing under the laws of the Philippines, with business address at 3/F Executive Building Centre, Sen. Gil Puyat Avenue corner Makati Avenue, Makati City, duly authorized and represented herein by its **VICE-PRESIDENT and COO MR. JOSEPH B. IMBAO** and herein referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, the Implementing Rules and Regulations of Republic Act No. 9593 or the Tourism Act of 2009 authorizes the PROCURING ENTITY to develop and administer a maintenance program for building, grounds, facilities equipment, repair, improvement and/or enhancement as well as security programs and measures;

WHEREAS, pursuant to this, the PROCURING ENTITY intends to engage the services of a security agency to provide security services over its premises;

WHEREAS, the SUPPLIER has submitted its bid for the Procurement of Security Services for the amount of **Eight Million Six Hundred Thirty-Seven Thousand Eight Hundred Thirteen Pesos (PhP8,637,813.00)**, inclusive of applicable taxes;

WHEREAS, after the evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through **BAC Resolution No. 2023-129** has declared the SUPPLIER to be the bidder with the Lowest Calculated and Responsive Bid (LCRB) and has recommended the award of the contract to the SUPPLIER to commence **upon receipt of the Notice to Proceed until 31 December 2023;**

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications or Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the PROCURING ENTITY's bid evaluation;
 - d. Performance Security;
 - e. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
3. In consideration for the sum of **Eight Million Six Hundred Thirty-Seven Thousand Eight Hundred Thirteen Pesos (PhP8,637,813.00)**, inclusive of applicable taxes; or such other sums as may be ascertained, the SUPPLIER agrees to provide security services in accordance with its Bid.
4. The PROCURING ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
