**Contract for the Procurement for the Ground Handling Services for the French dive
Philippines Ambassadors Event in Palawan**

This Contract for the Procurement for the Ground Handling Services for the French dive Philippines Ambassadors Event in Palawan ("Agreement") is made this JUN 30 2023 2023, in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Senator Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY VERNA COVAR-BUENSUCESO** ("Procuring Entity");

and

CCT.168 TRAVEL AND TOURS CORP., a private entity with business address at Unit 501 The Richmond Plaza, 21 San Miguel Avenue corner Lourdes St., Ortigas Center, Pasig, represented herein by its **GENERAL MANAGER, PLACIDA S. FAUSTINO** (the "SUPPLIER");

WITNESSETH:

WHEREAS, the Procuring Entity invited Bids for certain goods and services, particularly ground handling service to provide the required logistics and other arrangements for the French Celebrity Dive Ambassadors Event on July 12 to 20, 2023 in El Nido, Palawan and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION THREE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED PESOS (Php2,398,500.00)**, inclusive of applicable taxes (hereinafter called "the Contract Price")

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications or Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the **PROCURING ENTITY**'s bid evaluation;
 - d. Performance Security;

- e. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
3. In consideration for the sum of **Two Million Three Hundred Ninety-Eight Thousand Five Hundred Pesos (PhP2,398,500.00)**, inclusive of applicable taxes; or such other sums as may be ascertained, the SUPPLIER agrees to provide security services in accordance with its Bid.
4. The PROCURING ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
