WITNESSETH:

WHEREAS, the Civil Service Commission (CSC), through CSC Memorandum No. 1 s. 2001, established the Program on Awards and Incentives for Service Excellence (PRAISE) system, an incentive awards system intended to provide both monetary and nonmonetary awards and incentives to recognize, acknowledge, and reward productive, creative, innovative, and ethical behavior of employees;

WHEREAS, the PROCURING ENTITY will hold its PRAISE AWARDS for two hundred forty-eight (248) PRAISE Awardees;

WHEREAS, the PROCURING ENTITY is in need of memorabilia to be given to the PRAISE awardees in the form of gift certificates or gift checks;

g) the Entity's Notice of Award.

- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
 - 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
