Dear Mr. Balayan:

We are pleased to notify you that your Bid dated 20 November 2020 for the Procurement of Consulting Services for the Philippine International Dive Expo (PHIDEX) Virtual Platform (DOT-BAC REI No. 2020-010 2nd Posting) with a Total Contract Price of Thirteen Million Seven Hundred Ninety-Eight Thousand Four Hundred Philippine Pesos (PhP13,798,400.00.00), inclusive of applicable taxes, is hereby accepted, subject to the agreements made during the Negotiation, as follows:

• The Service Provider confirms that resource persons/speakers reflected in the proposal are not final, can be replaced, and is subject to the end-user's approval.

The contract duration shall be four (4) months, effective from the receipt of the Consultant of the Notice to Proceed.

- Cash or cashier's/managers check issued by a Universal or Commercial Bank <u>or</u> Bank draft/guarantee <u>or</u> irrevocable letter of credit issued by a Universal or Commercial Bank, payable to the Philippine Department of Tourism in the amount equivalent to at least five percent (5%) of the Total Contract Price or equivalent to at least **PhP689,920.00** <u>or</u>
- Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in the amount equivalent to at least thirty percent (30%) of the Total Contract Price or equivalent to at least **PhP4,139,520.00**.
